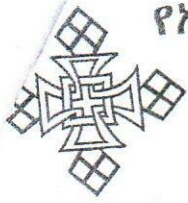



We remain committed to working closely with your esteemed office to resolve these matters in a manner that will enable the continued provision of essential services to the people of Oromia.

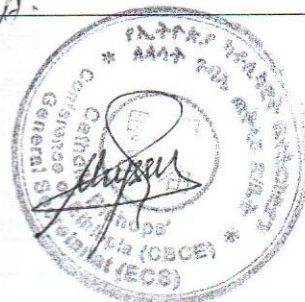

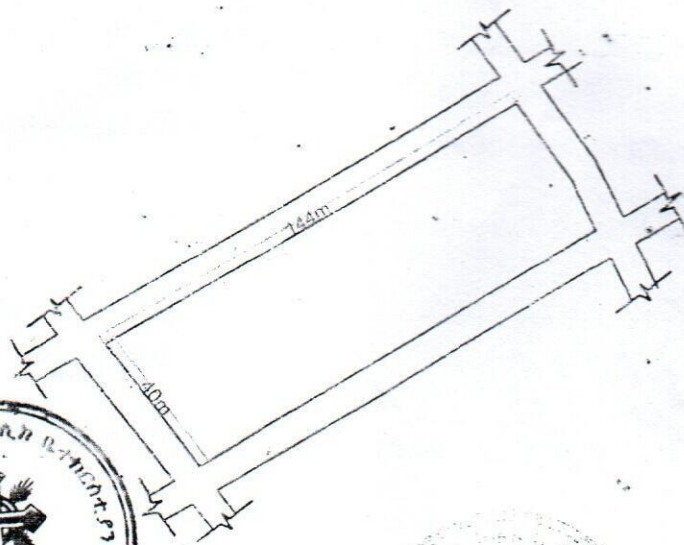
